Commissioners' Meeting Minutes for June 22, 2021

I. CALL MEETING TO ORDER

AUDIENCE PARTICIPATION

- A. Greg Morse Abatement Request; Mr. Morse was invited to meeting but did not attend.
 - 1. Mr. Morse had high usage in January 2021
 - a) Mr. Morse called Lisbon Water Dept. to find out if the reading was accurate; it was. Mr. Morse then tried to find the source of the leak but was unable to. He then compared his meter reading to ours and let us know they were different. We investigated and let him know that ours was accurate.
 - b) Lisbon Water Department investigated at the office to see why our meter reading was different from the one Mr. Morse reads.
 - c) Mr. Alexander saw a spot under a 4-wheeler (at the end of a trailer) where the grass was green and suspected this is where the leak was but Greg did not think so.
 - d) Mr. Morse asked for help; LWD gave him EJP's contact information but EJP was not able to find a leak either
 - e) Mr. Morse had Longchamps in to dig a couple of possible locations with no luck in finding it
 - f) Mr. Alexander called Maine Rural Water Association; they listened and heard a leak. The area was dug and MRWA could no longer hear the leak.
 - g) The leak was eventually found under the trailer where Mr. Alexander had seen the green grass. When the tenant moved out, Mr. Morse was able to move the trailer and find the leak.
 - 2. Mr. Morse worked very hard to find the leak and to fix it.
 - 3. The abatement amount (if approved) would be \$384.75 as determined using the formula in our terms and conditions. Mr. Morse was given a copy of our Terms and Conditions when he asked about an abatement.
 - 4. Mr. McLean made motion to approve, Mr. Bickford 2nd motion followed by a 3/0 vote to approve.
